

**Tuition & Fees Schedule  
(Grades K-7)**  
School Year: 2018-19

**Annual Tuition:** 2018-19 Annual Tuition for Grades K-7 is **\$31,000**.

**Sibling Discount:** 2018-19 Annual Tuition is **reduced by \$2,000** for each additional child enrolled. The Sibling Discount is applied to each younger student and is only applicable when more than one child in the same family is enrolled during the same School Year.

**Early Enrollment:** Students **enrolled by December 18, 2017** (signed Enrollment Agreement and deposit paid) will **receive a \$2,000 discount** on the 2018-19 Annual Tuition. The discount will be applied to the first tuition payment by waiving the New Student Fee.
